CONTINUING PERSONAL GUARANTY OF ACCOUNT

For and in consideration of Riback Supply Company, Inc., Magic City Wholesale Plumbing, Inc., McNally Plumbing & Cabinetry and/or Designer Kitchens & Baths (DKB), (hereinafter referred to as Seller) extending credit to _____, (hereinafter referred to as Applicant), the undersigned, (hereinafter referred to as Guarantors), agree to pay for all items of merchandise delivered to or at the request of Applicant before the last day of the month following the month of purchase.

Guarantors agree that each of the terms and conditions of sale stated on the Seller's invoices shall be a term of the contract of each sale from Seller to Applicant. **The Guarantors acknowledge that a monthly Service Charge will be added on all sums due to Seller that have not been paid by the end of the month following the month of purchase. The Guarantors agree to promptly pay said Service Charge.** The Service Charge shall be one percent, (1%) per month (12% A.P.R.) or the highest rate allowed by contract in the state in which this application is executed, whichever is lower. Additional service charges, computed on the same basis, shall be added each month thereafter until Seller receives full payment. Waiver of any one or more Service Charges shall not be deemed to be a waiver of future Service Charges. The Guarantors further agree that with regard to such Service Charges, the Guarantors and Seller are parties to a written contract. If Seller commences litigation in order to secure payment of any sums due to it from Applicant, Guarantors agree to pay all costs of collection, including reasonable attorney fees, in addition to all sums due. The Guarantors warrant that this agreement has been carefully read, that they understand the same, and understand it to be a legally binding contract which remains in full force and effect until withdrawn in writing by Guarantor.

The Guarantors, jointly and severally, in consideration for monthly billing privileges being extended to the above named applicant, do hereby unconditionally guaranty and promise to pay any and all obligations of said Applicant which have in the past or may in the future be owing to Seller on the open account or otherwise, including Service Charges and all costs of collection including reasonable attorney fees. Guarantors further waive all presentments, demands for performance, notices of nonperformance, notices of protest, notices of dishonor and notices of acceptance of this guaranty and of the incurrence or modification of existing or additional indebtedness. No delay in the enforcement of this guaranty shall affect the liability of any of the undersigned personal guarantors.
